

Draft Minutes of the Meeting of Keelby Parish Council held in the Village Hall on Tuesday 3rd October at 7.00pm

1 To receive apologies and reasons for absence Ref 17/135

3 To approve draft minutes of the Parish Council Meeting held on 5th September 2017. Ref 17/137

Resolved to approve as a true record, with the amendment that the word annual was removed, as was ordinary meeting of council.

4 Public Question Time 10 Minutes Ref 17/138

Eve Darwood spoke about the new community group which has been formed to try and bring the smaller groups in the village together to work towards making improvements and holding events in the village.

A question was raised as to why the gap in the hedge on the playing field has been blocked by a temporary fence – the hedge is being damaged by people walking through the gap, and it will also give the new plants a chance to establish.

5 County Council matters Ref 17/139 – Cllr Turner joined the meeting at 7.10pm.

The issue of dogs being walked after the streetlights have been switched off was raised, and an increase in dog mess in the village.

Cllr Turner has contacted LCC childrens services about the issues with the Youth Club, and these are now being resolved.

Cllr Turner left the meeting at 7.25pm.

6 Clerk's report Ref 17/140

Police report received – on going issues at Sports Pavilion have been resolved.

Correspondence has been received from the PARK group, stating that they have had a meeting which was not attended by any councillors. Council were unaware of the meeting.

7 District Council matters Ref 17/141

A report was circulated via email before the meeting.

Grants may be available to install a CCTV system at the sports pavilion.

Consultation is now open about the green bin / garden waste collection scheme. A meeting will be held at the village hall on October 9th, 3.00pm to 6.00pm.

Keelby designated household waste tip is Market Rasen.

8.To receive any reports from external organisations Ref 17/142

A) Library / Youth Club – The primary school are now using the library again.

The issues surrounding the Youth Club are now being dealt with, and the community group are looking to employ a new Youth Worker.

Cllr Lawrence left the meeting – 7.37pm.

B) Village Hall – the windows are being replaced, and the ladies toilet has now been redecorated. PAT testing has been done.

C) Sports Association - A meeting was held on October 1st. Several sports clubs are looking to recruit new members and volunteers. The Sports Association have requested that the terms of reference be amended to allow for other community groups to become part of the committee. The effect of this on the charitable status will need to be looked at. The land was given for the provision of sport in the village and this cannot be altered.

It was proposed to seek legal advice and report to next meeting.
