Clerk has had a telephone conversation with the representative from Playdale who has given reassurance that the equipment in the plan is for under 5's Cllr Indian stressed that although equipment may be suitable for children older than this, the area is designated for under 5's. A meeting with Playdale will take place soon where they will present the plans and answer any questions.
